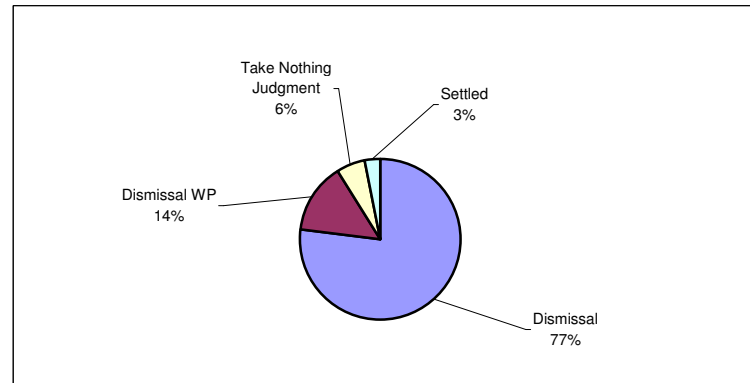


This table lists all of the credit card, automotive deficiency and other debt court cases that we have defended and resolved from the year of 2005 through April, 2009.

Almost all of our dismissals listed are non-suits. This means that the creditor has voluntarily dismissed its case, but reserves the right to re-file. Those that are listed as Dismissal WP (or "with prejudice") means that they have given up their right to re-file.

Most of these cases involved debt buyer Plaintiffs. Debt buyers have a harder time than original creditors in proving their cases because it can be harder for them to obtain documents.
